THE SECURITIES COMMISSIONER OF THE STATE OF NORTH DAKOTA TO ARROW ENVIRONMENTAL REMEDIATION OPERATIONS AND HANK M. KENDRICK AND THEIR OFFICERS, DIRECTORS, AGENTS, AND EMPLOYEES:

The Securities Commissioner has a reasonable basis to believe that the Respondents have engaged in, are engaging in, or are about to engage in, acts, practices or transactions, as more fully described below, which are prohibited under Chapter 10-04 of the North Dakota Century Code (N.D.C.C.). It is necessary and appropriate in the public interest and for the protection of investors to restrain these acts, practices, or transactions of the Respondents.

- 1. The Respondents have offered for sale and sold notes, which are securities as defined in §10-04-02(13) N.D.C.C. The subject securities have not been registered with the Securities Commissioner under §10-04-07; §10-04-07.1; §10-04-08; or §10-04-08.1 N.D.C.C.; are not exempt securities under §10-04-05 N.D.C.C; and have not been offered for sale or sold in exempt transactions under §10-04-06 N.D.C.C. and were therefore offered and sold to residents of North Dakota in violation of §10-04-04 N.D.C.C.
- 2. The Respondents offered the above securities with the promise of a return of 20% on the investment. Such promise may be in violation of §10-04-15 N.D.C.C.
- 3. The Respondents have failed to register as dealers in violation of §10-04-10(1) N.D.C.C. The Respondents have failed to register any salesman in violation of §10-04-10(2) N.D.C.C.
- 4. The Respondents failed to respond to an inquiry of this office as sent on August 12, 1997 and again on September 3, 1997. This failure to respond is in violation of §10-04-16.1 N.D.C.C.

NOW, THEREFORE, IT IS ORDERED, pursuant to §10-04-16 N.D.C.C., that the Respondents immediately shall **CEASE AND DESIST**:

- 1. From offering for sale or selling in North Dakota the subject investment, or any other investment interest however denominated, unless and until such investment interests have been registered with the Securities Commissioner; provided, however, that nothing in this part of the order shall apply to exempt securities under §10-04-05 N.D.C.C. or to exempt transactions under §10-04-06 N.D.C.C.;
- 2. From offering for sale or selling investments in North Dakota unless and until they have registered with the Securities Commissioner as dealers or salesmen; provided, however, that nothing in this part of the order shall apply to exempt securities transactions under §10-04-06 N.D.C.C.;
- 3. From providing a guarantee on rates of return on investments or otherwise engaging in a fraudulent act while offering for sale or selling investments in North Dakota; and
- 4. From failing to comply with the reasonable requests for information from the Office of the Securities Commissioner in regard to your activities in offering for sale or selling investments in North Dakota.

NOTICE OF CIVIL PENALTIES

YOU ARE NOTIFIED that the above-cited violations are sufficient grounds for the imposition of civil penalties pursuant to §10-04-16(1) N.D.C.C. Securities Commissioner hereby orders payment of a civil penalty in the amount of \$10,000.

NOTICE OF RIGHT TO REQUEST HEARING

YOU ARE NOTIFIED that pursuant to §10-04-12 N.D.C.C. you may request a hearing before the Securities Commissioner if such a request is made in writing WITHIN FOURTEEN (14) DAYS AFTER THE RECEIPT OF THIS ORDER. The respondent has the right to be represented by legal counsel at the hearing.
