WHEREAS, on March 22, 1999, the Commissioner issued a Cease and Desist Order based on multiple violations of North Dakota securities laws, including violations of the registration and anti-fraud provisions of the Securities Act; and,

WHEREAS, on March 23, 1999, the Cease and Desist Order was sent to Bruce M. Follick and the Cease and Desist Order was received by Bruce M. Follick on March 26, 1999; and,

WHEREAS, respondent did not provide a request for hearing, nor did respondent deny any facts relied upon by the Commissioner underlying the Cease and Desist Order dated March 22, 1999.


NOW, THEREFORE, it is hereby Ordered that respondent, Bruce M. Follick is hereby assessed and shall make payment to the Commissioner, a civil penalty in the amount of \$20,000 for the violations set forth above and in the Cease and Desist Order dated March 22, 1999. The payment of the civil penalties are due and payable immediately upon receipt of this Order.

YOU ARE NOTIFIED that pursuant to §10-04-12 N.D.C.C. you may request a hearing before the Securities Commissioner if such a request is made in writing WITHIN TEN (10) DAYS AFTER THE RECEIPT OF THIS ORDER. The respondent has the right to be represented by legal counsel at the hearing.
