WHEREAS, on January 20, 1999, the Commissioner issued a Cease and Desist Order based on multiple violations of North Dakota securities laws, including violations of the anti-fraud provisions of the Securities Act; and,

WHEREAS, on January 20, 1999, the Cease and Desist Order was sent to David Johnson, at the address provided by David Johnson, via certified mail, return receipt; and,

WHEREAS, on January 29, 1999, the certified mailing to David Johnson was returned unopened; and,

WHEREAS, respondent did not accept service of the Cease and Desist Order, nor did respondent provide a request for hearing of deny any facts relied upon by the Commissioner underlying the Cease and Desist Order dated January 29, 1999.

NOW, THEREFORE, it is hereby Ordered that respondent, David Johnson, is hereby assessed and shall make payment to the Commissioner, a civil penalty in the amount of \$10,000 for the violations set forth above and in the Cease and Desist Order dated January 20, 1999. The payment of the civil penalty is due and payable immediately upon receipt of this Order.

NOTICE OF RIGHT TO REQUEST HEARING

YOU ARE NOTIFIED that pursuant to §10-04-12 N.D.C.C. you may request a hearing before the Securities Commissioner if such a request is made in writing WITHIN TEN (10) DAYS AFTER THE RECEIPT OF THIS ORDER. The respondent has the right to be represented by legal counsel at the hearing.


