WHEREAS, the LPL salesman for the account is Dirk P. Hausauer; and,

WHEREAS, the complaint contains allegations which, if proven, would constitute violations of Ch. 10-04, N.D.C.C., and these allegations have been made known to Respondent and his counsel, Craig Boeckel; and,


WHEREAS, the North Dakota Securities Commissioner is conducting an investigation of the activities of Dirk P. Hausauer in connection with this account and with other accounts of North Dakota residents; and,

WHEREAS, the North Dakota Securities Commissioner and Dirk P. Hausauer have reached an agreement whereby the salesman registration of Dirk P. Hausauer will be suspended pending the investigation.

NOW, THEREFORE, the North Dakota Securities Commissioner hereby Orders that:

1. The North Dakota salesman registration of Respondent, Dirk P. Hausauer, is hereby suspended until such time as the Commissioner has ~~concluded~~^(SV) ~~his investigation and~~^(SV) made a determination regarding further appropriate proceedings in this matter.



CONSENT TO ENTRY OF ORDER


