**NOTICE OF CIVIL PENALTY
AND RIGHT TO REQUEST A

WHEREAS, on August 7, 1998, the Commissioner issued a Cease and Desist Order based on multiple violations of North Dakota securities laws, including violations of the registration provisions of the Securities Act; and,

WHEREAS, on August 7, 1998, the Cease and Desist Order was sent to Kaizen International Consulting Corporation and the Cease and Desist Order was received by Kaizen International Consulting Corporation on August 18, 1998; and,

WHEREAS, respondent did not provide a request for hearing, nor did respondent deny any facts relied upon by the Commissioner underlying the Cease and Desist Order dated August 7, 1998.

NOW, THEREFORE, it is hereby Ordered that respondent, Kaizen International Consulting Corporation, is hereby assessed and shall make payment to the Commissioner, a civil penalty in the amount of \$20,000 for the violations set forth above and in the Cease and Desist Order dated August 7, 1998. The payment of the civil penalties are due and payable immediately upon the execution of this Order.

NOTICE OF RIGHT TO REQUEST HEARING

YOU ARE NOTIFIED that pursuant to §10-04-12 N.D.C.C. you may request a hearing before the Securities Commissioner if such a request is made in writing WITHIN TEN (10) DAYS AFTER THE RECEIPT OF THIS ORDER. The respondent has the right to be represented by legal counsel at the hearing.


