WHEREAS, on September 23, 1998, the Commissioner issued a Cease and Desist Order based on multiple violations of North Dakota securities laws, including violations of the registration and anti-fraud provisions of the Securities Act; and,

WHEREAS, on September 23, 1998, the Cease and Desist Order was sent to Lon Finkelstein at Public Communication Services, Inc. and the Cease and Desist Order was received by Lon Finkelstein on September 28, 1998; and,

WHEREAS, respondent did not provide a request for hearing, nor did respondent deny any facts relied upon by the Commissioner underlying the Cease and Desist Order dated September 23, 1998.


NOW, THEREFORE, it is hereby Ordered that respondent, Lon Finkelstein is hereby assessed and shall make payment to the Commissioner, a civil penalty in the amount of \$20,000 for the violations set forth above and in the Cease and Desist Order dated September 23, 1998. The payment of the civil penalties are due and payable immediately upon receipt of this Order.




