WHEREAS, on March 17, 1999, the North Dakota Securities Commissioner issued a Cease and Desist Order, Notice of Civil Penalty, and Notice of Right to Request a Hearing (Cease and Desist Order) against the above-named respondents; and,

WHEREAS, on March 31, 1999, the respondent, Michael Hammerschmidt made a request for hearing with regard to a related Subpoena Duces Tecum; and,


WHEREAS, no hearing was held as per that request and no timely response was made with regard to the letter of Mr. Hammerschmidt; and,

WHEREAS, The Commissioner has determined that further action against Respondent, Michael Hammerschmidt is unnecessary based on this apparent procedural defect.


