**THE SECURITIES COMMISSIONER OF THE STATE OF NORTH DAKOTA TO
ERIC MAASKE:**

WHEREAS, on April 10, 2001, The North Dakota Securities Commissioner issued a Cease and Desist Order, Notice of Civil Penalty, and Notice of Right to Request a Hearing (Cease and Desist Order) against Eric Maaske based on information that Respondent, Eric Maaske, acted as an agent of Respondent, Preferred Trust and Management, LTD., and that Eric Maaske has offered for sale and/or sold investment(s) in Preferred Trust and Management; and,


WHEREAS, further investigation has revealed that the activity discussed above and described in the Cease and Desist Order occurred outside of North Dakota and involved non-residents of North Dakota. Stated another way, this activity did not take place in or from North Dakota, nor did it relate to North Dakota residents; and,

WHEREAS, the Securities Commissioner has determined that taking enforcement action against non-residents of North Dakota based on securities sales to non-residents of North Dakota, while the transactions occur out of the State of North Dakota, is not in the public interest.

NOW, THEREFORE, IT IS ORDERED that the Cease and Desist Order, Notice of Civil Penalty, and Notice of Right to Request a Hearing, as issued on April 10, 2001 is hereby vacated.
