**THE SECURITIES COMMISSIONER OF THE STATE OF NORTH DAKOTA TO  
RODNEY J. DUNCKLEE:**

WHEREAS, on April 10, 2001, the North Dakota Securities Commissioner issued a Cease and Desist Order, Notice of Civil Penalty, and Notice of Right to Request a Hearing (Cease and Desist Order) against Rodney J. Duncklee based on information that Respondent, Rodney J. Duncklee, acted as an agent of Respondent, Preferred Trust and Management, TLD., and that Rodney J. Duncklee has offered for sale and/or sold investment(s) in Preferred Trust and Management, LTD.; and,

WHEREAS, further investigation has revealed that the activity discussed above and described in the Cease and Desist Order apparently occurred outside of North Dakota and involved non-residents of North Dakota. It does not appear that this activity took place in or from North Dakota, nor does it appear that the activity relates to North Dakota residents; and,

WHEREAS, the Securities Commissioner has determined that taking enforcement action against non-residents of North Dakota based on securities sales to non-residents of North Dakota, while the transactions occur out of the State of North Dakota, is not in the public interest.

NOW, THEREFORE, IT IS HEREBY ORDERED that the Cease and Desist Order, Notice of Civil Penalty and Notice of Right to Request a Hearing, dated April 10, 2001, as referenced above, is hereby vacated.
