WHEREAS, on April 10, 2001, the North Dakota Securities Commissioner issued a Cease and Desist Order in the above-captioned matter; and,

WHEREAS, Respondent, Tracy Velazques, received a copy of the Cease and Desist Order on April 12, 2001; and,

WHEREAS, Respondent, Tracy Velazques, did not request a hearing on the above-captioned matter;

NOW, THEREFORE, the North Dakota Securities Commissioner hereby Orders that the Respondent, Tracy Velazques, shall pay to the North Dakota Securities Commissioner the sum of **twenty thousand dollars (\$20,000)** as a civil penalty based on the violations discussed in the Cease and Desist Order dated April 10, 2001.
