**NOTICE OF CIVIL PENALTY

WHEREAS, on March 29, 1999, the Commissioner issued a Cease and Desist Order based on multiple violations of North Dakota securities laws; and,

WHEREAS, on March 29, 1999, the Cease and Desist Order was sent to Santoro's Gourmet Foods, Inc., and the Cease and Desist Order was received by Santoro's Gourmet Foods, Inc. on April 1, 1999; and,

WHEREAS, respondent did not provide a request for hearing, nor did respondent deny any facts relied upon by the Commissioner underlying the Cease and Desist Order dated March 29, 1999; and,

WHEREAS, respondent provided additional information, under Subpoena Duces Tecum, which demonstrated that respondent sold unregistered securities in Santoro's gourmet Foods, Inc. to Seventeen (17) North Dakota residents,

NOW, THEREFORE, it is hereby Ordered that respondent, Santoro's Gourmet Foods, Inc. is hereby assessed and shall make payment to the Commissioner, a civil penalty in the amount of \$17,000 for the violations set forth above and in the Cease and Desist Order dated March 29, 1999. The payment of the civil penalties are due and payable immediately upon receipt of this Order.

NOTICE OF RIGHT TO REQUEST HEARING

YOU ARE NOTIFIED that pursuant to §10-04-12 N.D.C.C. you may request a hearing before the Securities Commissioner if such a request is made in writing WITHIN TEN (10) DAYS AFTER THE RECEIPT OF THIS ORDER. The respondent has the right to be represented by legal counsel at the hearing.
