THE SECURITIES COMMISSIONER OF THE STATE OF NORTH DAKOTA TO
TELEVISION SALES CORPORATION, MARK GLASER, CHRIS ABBOTT, ALAN D.
MASON, AND ANY OTHER OFFICERS, DIRECTORS, AGENTS, SERVANTS AND
EMPLOYEES OF TELEVISION SALES CORPORATION

WHEREAS, it appears that Television Sales Corporation, has
offered for sale franchises to residents of North Dakota;

WHEREAS, Television Sales Corporation is not registered with
the Securities Commissioner to offer or sell franchises, and

WHEREAS, it appears to the Securities Commissioner that
Television Sales Corporation, Mark Glaser, Chris Abbott, Alan D.
Mason and other officers, directors, agents, servants or
employees of Television Sales Corporation are engaging in, have
engaged in, or are about to engage in acts or practices which may
constitute violations of the North Dakota Franchise Investment
Law (Chapter 51-19 of the North Dakota Century Code);

NOW, THEREFORE, IT IS ORDERED that Television Sales
Corporation, Mark Glaser, Chris Abbott, Alan D. Mason and any
other officers, directors, agents, servants and employees of
Television Sales Corporation cease and desist from:

1. Engaging in acts and practices in violation of Chapter 51-19 of the North Dakota Century Code; and/or

2. Advertising, offering for sale or selling any franchise, business opportunity, investment opportunity, distributorship or similar device however denominated, until they are registered with the Commissioner's office.

YOU ARE NOTIFIED that a hearing will be held in this matter if a request for such hearing is filed in writing by any interested party within ten days after the receipt hereof.
