THE SECURITIES COMMISSIONER OF THE STATE OF NORTH DAKOTA TO
WORLDWIDE TREASURE BUREAU, SAMUEL E. COX, AND ANY OTHER OFFICERS,
DIRECTORS, AGENTS, SERVANTS AND EMPLOYEES OF WORLDWIDE TREASURE
BUREAU:

1. It appears to the Securities Commissioner that Worldwide
Treasure Bureau and Samuel E. Cox, ("Respondents"), have engaged,
are engaging, or are about to engage in certain acts, practices, or
transactions, as more fully described below, which are prohibited
under Chapter 10-04 of the North Dakota Century Code ("N.D.C.C.").
It further appears to the Securities Commissioner that it is
necessary or appropriate in the public interest or for the
protection of investors to restrain these acts, practices, or
transactions.

2. The Respondents have offered for sale, solicited an order
or offer to buy, or sold in North Dakota securities in the form of
investment contracts or notes.

3. The subject securities have not been registered with the
Securities Commissioner under Section 10-04-04, N.D.C.C.; are not
exempt securities under Section 10-04-05, N.D.C.C.; and have not

been offered for sale or sold in exempt transactions under Section 10-04-06, N.D.C.C.

4. The Respondents are not registered as dealers or salesmen under Section 10-04-10, N.D.C.C.

NOW, THEREFORE, IT IS ORDERED, pursuant to Section 10-04-16, N.D.C.C., that Worldwide Treasure Bureau, Samuel E. Cox, and all other officers, directors, agents, servants, and employees Worldwide Treasure Bureau immediately cease and desist:

A. From offering for sale or selling in or from North Dakota the subject securities, or any other security however denominated of any issuer, unless and until such securities have been registered with the Securities Commissioner; provided, however, that nothing in this part of the order shall apply to exempt securities under Section 10-04-05, N.D.C.C., or to exempt transactions under Section 10-04-06, N.D.C.C.

B. From offering for sale or selling in or from North Dakota the subject securities, or any other security however denominated of any issuer, unless and until they have been registered as dealers or salesmen with the Securities Commissioner; provided, however, that nothing in this part of the order shall apply to exempt transactions under Section 10-04-06, N.D.C.C.

YOU ARE NOTIFIED that the above-cited violations, if proven, are sufficient grounds for the imposition of a civil penalty, pursuant to Section 10-04-16, N.D.C.C.

YOU ARE ALSO NOTIFIED that any person aggrieved by this order may request a hearing before the Securities Commissioner if such a request is made within ten days after receipt of this order.
